**DECISION**

Pursuant to Article 155 of the code of administrative procedure (uniform text, Journal of Laws of 2013, No. 647, as amended) and Article 72a paragraph 1 of the act of 3<sup>rd</sup> October 2008 on the provision of information on the environment and its protection, public participation in environmental protection and environmental impact assessments (Journal of Laws of 2013, item 1235), after considering the request of the company Wiatromill Sp z o. o., Al. Jerozolimskie 56c, 00-803 Warszawa on the transfer of the decision issued by the Head of Widuchowa Commune on environmental conditions No. GNG.7624/2/2010-2014 of 23.09.2014 for the investment consisting in the construction of "A complex of wind power plants Widuchowa with the accompanying infrastructure" located near the village of Żelechowo, Widuchowa commune, issued for the company "Domrel" Biuro Usług Inwestycyjnych, Sp. z o.o., ul. Odzieżowa 12C/1, 71-502 Szczecin

Odzieżowa 12c/1, 71-502 Szczecin, in the part concerning the execution of 3 wind power plants, erection yards, access roads and medium voltage electric power cable lines, and tele-technical cable lines on the plots of land designated with the numbers 205 (EW2), 121/24 (EW4) and 353/2, with access and reconstructed roads, and electric power [...] on the plots of land designated with the numbers 295/2, 366, 374, 818, 95, 244, 425, 778, 801, whereas the plots of land No. 295/2, 366, 374, 818, 95, 244, 425, 778, 801 shall also be used for the execution of the part of the undertaking for which the Environmental Decision is not transferred (on the plots of land No. 295/2, 366, 374, 818, 95, 244, 425, 778, 801 are located communal roads that can be used for both undertakings, and moreover, the medium voltage electric power cables and teletechnical cable lines can run through those plots for both undertakings), from the entity to which such decision was issued, i.e. the company "Domrel" Biuro Usług Inwestycyjnych Sp. z o.o., ul. Odzieżowa 12c/1, 71-502 Szczecin to the applicant, the company Wiatromill Sp. z o.o. Al. Jerozolimskie 56c, 00-803 Warsaw, which represents that it accepts the conditions contained in the decision.

Such application should be filed no later within four years from the date on which the decision on environmental conditions became final.

The parties may appeal against this decision to Self-government Appeal Court in Szczecin, with my intermediation, within 14 days from the date of receipt of this decision.
